

## **VIRGINIA CONFERENCE INDEMNITY & MEDIA RELEASE AGREEMENT**

I acknowledge and agree that I have read this entire Virginia Conference Indemnity & Media Release Agreement (hereinafter the "Agreement"). I acknowledge and agree that I am indemnifying The Virginia Conference of The United Methodist Church (hereinafter "The Virginia Conference") against any claims by me to recover damages, costs, fees, and expenses for personal injuries, property damage, and death as a volunteer. I also acknowledge and agree that I am providing the Virginia Conference with a media release in ¶ 2 below. I understand that the activity (defined below) I will be participating in may involve risk of physical injury and may involve hard physical labor, heavy lifting and other strenuous activity, and that some activities may take place on ladders and building framing other than at ground level. I certify that I am in good health and physically able to perform this type of work

2. I authorize the making of photographs, motion pictures, videotapes, recordings, or other memorializing of said event and my participation therein, and the publication or other use thereof. I waive any right to compensation therefore or any right that I otherwise might have to limit or control such making or use.
3. I warrant and represent that I am eighteen years of age or over, and am fully aware of and understand the terms and legal consequences of the signing of this Agreement. If I am a guardian for a minor signing this Agreement, I warrant and represent that I explained the terms of this Agreement to the minor child.
